# **National Planning Framework**

Questions still outstandin regarding the impending NPPF - Rural communities, including those in Marbury Ward, should be particularly alert to several aspects of the proposed changes to the English National Planning Policy Framework (NPPF)

### 1. Pressure for Increased Rural Development

The proposed NPPF revisions aim to boost housebuilding, including in rural areas. While addressing housing need is important, for rural communities these risks:

- Loss of greenbelt and countryside: Relaxed restrictions could lead to urban sprawl and erosion of the rural character.
- **Development on agricultural land**: Threatening local farming viability and food security.
- **Overburdened infrastructure**: Roads, schools, GP services, and utilities could be stretched beyond capacity, without guaranteed infrastructure upgrades beforehand.

We continue to stress the need for infrastructure-first development and protection of high-value agricultural land.

### 2. Weakened Local Voice in Planning Decisions

Under the new framework:

- Local Plans must align tightly to central targets, and councils face penalties if they cannot meet "objectively assessed" housing need.
- Neighbourhood Plans which have empowered villages to shape growth may become more limited in resisting unwanted developments if housing delivery targets aren't met.

It is imperative that we defend local democratic control of planning and reinforce the status of Neighbourhood Plans.

#### 3. Strain on Environmental Protections

Although the Government is promoting "beautiful and sustainable places," in practice:

- **Biodiversity and environmental protections** could be side-lined if councils are under pressure to grant permissions quickly.
- Carbon neutral aspirations for rural developments could be sacrificed for speed and volume.

### 4. Unclear Impact of the "Infrastructure Levy"

The Infrastructure Levy, which replaces Section 106 agreements, could:

- Reduce the ability of local councils to negotiate specific local benefits (like funding for a new community hall or play area).
- Result in **smaller rural developments paying less proportionally**, leading to fewer public benefits being delivered in rural villages compared to urban areas.

We must push for a fair share of infrastructure investment into rural areas tied to any new developments.

### 5. Risk of "Cookie-Cutter" Developments

The drive for faster housing delivery could favour large volume housebuilders, risking:

- **Identikit housing estates** poorly suited to local rural character.
- Loss of the distinctive architecture and heritage that defines villages and rural settings.

We must advocate for design codes that reflect and enhance local rural character, not obliterate the charm of our rural villages with cheap building materials, method and design.

For rural communities like Marbury Ward, the big concern with the new NPPF is that while it claims to "streamline" planning, it risks:

- Losing local say
- Damaging the countryside
- Delivering inappropriate or poorly supported growth

Our position is clear: support appropriate, sustainable development that meets local needs (especially affordable homes for young families and downsizers) — but **resist top-down, volume-driven development** that harms community character and infrastructure resilience. We'll share more information once received.

# **Devolution – Cheshire & Warrington**

Another key topic - Devolution offers Cheshire West and Chester the potential for greater local control, funding, and flexibility to shape services around community needs. But with opportunity comes challenge — from accountability concerns to fears of added bureaucracy. A few further general thoughts below, whilst more specific information is published:

### Potential Pros of Devolution:

### 1. Greater Local Control and Decision-Making

CW&C would gain more direct control over key powers like transport, skills, and economic development.

Faster, locally sensitive decisions could be made without waiting for national government approval.

### 2. Targeted Investment and Funding

The devolution deal would unlock additional funding streams that could be invested in local priorities (e.g., town centre regeneration, skills training, green initiatives).

It can help address specific borough challenges like housing, infrastructure, or poverty.

### 3. Stronger Voice in the Region

CW&C would have a bigger influence across the sub-region (Cheshire & Warrington) through the devolved arrangements, shaping larger strategic projects (e.g., transport corridors, inward investment zones).

### 4. Joined-up Public Services

Devolution enables better alignment between councils, health services (NHS Cheshire West), education providers, and the private sector ...

For example, improvements in health outcomes (Marmot priorities) could be pursued more effectively through a locally-driven model.

### 5. Economic Growth Opportunities

Cheshire West has a strong industrial base. Devolution could help deliver projects that boost business growth, innovation hubs, rural economy diversification, and improve local productivity.

#### Potential Cons of Devolution:

### 1. Financial Risks and Unfunded Responsibilities

Central government may transfer powers without transferring enough funding ("devolution on the cheap"), leaving CW&C financially exposed

Savings targets could be made harder if new devolved powers bring extra costs)

#### 2. Complexity and Duplication

More local powers can mean more complexity: risk of overlapping governance structures, confused accountability, or 'postcode lotteries' where service quality varies across areas.

### 3. Capacity Challenges

CW&C would need strong leadership, skilled officers, and systems to manage new responsibilities well (e.g., complex areas like transport franchising, skills commissioning).

Senior officer capacity is already stretched

### 4. Public Engagement and Accountability Issues

Residents may feel disconnected from new devolved bodies (e.g., Combined Authorities or Mayor-led models) unless there's clear communication and democratic oversight.

A risk of "elite capture" where a small group shapes decisions without broader community input.

**Devolution offers CW&C significant opportunity** — greater influence, better-targeted investment, and stronger local control — but only if capacity, funding, and governance are managed well. It aligns with your leadership instincts: fast, decisive, pragmatic action could deliver real outcomes for residents but would need careful handling of risks and strong teamwork across the borough. With local pressures in Cheshire West & Chester, Cheshire East and Warrington raising concerns, we still feel that 2026 is too soon and would recommend that any plans be postponed to 2027. This would also coincide with Cheshire West & Chester's Borough elections.

### Winnington Lime Bed Solar Park – (Appeal)

Planning Appeal: APP/A0665/W/25/3359308

Application Reference: 23/02766/FUL

The applicant has appealed the decision to refuse the development by CWaC. As much as the proposed development is outside Marbury Ward, the impact on our communities and infrastructure is significant. A response to the Appeal has been submitted by Marbury Cllrs representing the villages effected in Marbury.

### The key concerns included:

- 1. Infrastructure Harm to Communities
- 2. Impact on Health and Well-being
- 3. Congestion and Emergency Access Risk
- 4. Environmental and Economic Damage
- 5. No Community Benefit

# Northwich Regeneration Update

### **Weaver Square**

- The Council is currently in the process of procuring a development partner for Weaver Square.
- The development partner will work with the Council to deliver a residential-led scheme on this key regeneration site in Northwich town centre.
- As the procurement process is a commercial sensitive stage of the project, there will be no further updates until a decision has been reached.
- CWaC are currently targeting July 2025 for a Cabinet decision.

#### **Northwich Market**

- Public engagement on plans for the new market at Barons Quay has commenced and will run from Tuesday 6th May until Monday 9th June 2025.

### **Northwich Library**

The required scaffold/propping installations on the third gable are in place on the west elevation.

- CWaC have received the RIBA stage 3 design outcome and are now progressing to planning application.
- To fully understand any further limitations of the existing building, and to further de-risk the refurbishment phases, some soft stripping works will soon be undertaken throughout the building. Anticipated to begin in April following contractor appointment in March.

- Following the drop in event the planning application based on Stage 3 designs will be submitted.
- The full repair and refurbishment works are expected to be completed Summer/Autumn 2026

# **Buildings/Surveys**

- Topographical survey has been commissioned (of the whole complex) to aid further refurbishment works on the wider site.
- A Contractor has now been appointed for the refurbishment of the barns, works will start this week and take 12 weeks to complete.
- Dialogue taking place with the Sub Aqua Club to relocate to one of the refurbished barns, this will also facilitate the new ancillary car park works
- Demotion approval has been granted for the red brick 'Children's Nursery building' this will be removed during June

### **Lease Negotiations**

- Property specialists Cushman & Wakefield will be sending out a Memorandum of Understanding (MOU) for the new management model, to all clubs to sign up to prior to HoT's negotiation.
- There has been positive feedback from the clubs from these meetings who have appreciated that this element is progressing.

### New Artificial Grass Pitch's (AGP)

- The new 3G AGP is complete with a temporary licence is being drafted with Cheshire FA to operate the facilities whilst the long-term lease agreement are negotiated.
- The Sand AGP (opposite the Rugby Social Club) refurbishment will be complete in a couple
  of weeks time again with a temporary licence being drafted with operator Sporting
  Communities.

### Wider Programme- next phase

 Continued building viability assessments taking place, new car park construction later in the year and improvements to changing facilities out of sports seasons over the next 12 months.

### Last PSG was held on 11 April 2025

- Community Safety continue to work with Northwich BID, Baron's Quay and Winsford Cross Shopping Centre to provide a joined-up approach to anti- social behaviour within our shopping areas
- Likewise with the fire service to information share on fires being started in key locations across the area, especially in light of the recent warmer and drier weather
- Problem Solving Group continues to meet once a month with colleagues from Housing providers and the local Police unit to information share
- Designing Out Crime reports completed by Police for both Winsford Cross Shopping Centre/Public Realm and Town Park Winsford in light of recent ASB and how this can best be mitigated on a multi-agency basis.

Chris Doyle has now retired and has been replaced by Sam Chapman as the Community Safety Officer for Northwich and Winsford areas.

#### Northwich

Slight increase in ASB in the town centre, the issues around the homeless and street teams hopefully have died down after the arrest of suspects for shoplifting offences.

Week commencing 19th May will see a week of focus force wide on Knife crime under Op Sceptre which is aimed at reducing knife crime.

### Village Halls Main Grants

Grants are available up to £75,000 to support larger improvement projects to rural community buildings in England such as full refits and extensions (this will cover some of the rural areas in the Northwich/Winsford area). Main grants scheme for village halls - ACRE

London Hearts has launched this scheme with the aim of increasing the number of AEDs to help save lives. "As a charity we understand it is not always possible to install a public access Defibrillator and people's needs differ particularly in the workplace."

The fund is moving far quicker than they initially anticipated given the limited funding requirement, so they are allocating on a first come first basis as to avoid any disappointment. Anyone can apply, including the council.
