## ANTROBUS PARISH COUNCIL

## AFFORDABLE HOUSING SCHEME

The project was to provide a small development of affordable houses for shared ownership or rent. This would enable local people to stay in the community and ensure affordable homes in Antrobus in perpetuity. We started by forming a working party consisting of members of Antrobus Parish Council. As there were no other rural housing projects in Vale Royal guidelines, data and information was gathered over a period of months from a wide variety of sources. A parish-wide questionnaire was distributed and the results analysed. An open meeting was held to discuss the proposals with the villagers. Having received a favourable response to the presentation a decision was made to progress further. Meetings with housing associations were held in order to determine a suitable partner. A second questionnaire was carried out to determine specific needs and a search was begun for an acceptable site. In spite of some set-backs in obtaining adequate funding and suitable land these were eventually overcome and a planning application was submitted. A further public meeting was held and planning permission obtained.

Initially, we saw the scheme as probably two or four houses for shared ownership. We soon became aware of the need for rented properties. Changes in national and local social and economic trends caused us to constantly adapt to meet changing circumstances. Thus our final planning submission was for six rented and two shared ownership houses. Later two further houses for rent were built.
