Marbury Update April 2025

Summary of National issues impacting locally:

- Min Wage + NI Changes these increases come into place from this month, impacting SMEs / High Street and Hospitality as well as larger businesses operating in the Borough. This will also have an effect on 'bought-in' services used by the Council with the full extent on this year's expenditure still to be confirmed.
- Farm Inheritance Tax Along with Esther McVey MP, we continue to voice concern and highlight the ramifications of this change on our farming community. It is a very short-sighted policy that will raise a relatively small sum for the Treasury but have huge detriment for our farming communities for future generations, restricting investment, food security and either fragmentation of land ownership or further consolidation of our farmland into large corporates/pension funds. Eitherway this is an unnecessary move by the Government causing irreversible damage to multi-generational family farms across the Borough



Devolution – Cheshire & Warrington

Devolution – the government consultation is on-going - <u>Cheshire and Warrington devolution</u> <u>consultation - GOV.UK</u>. This is a statutory consultation which always happens when local areas go for devolution and the results are NOT shared with the local authorities.

- A Shadow Combined Authority will need to be in place by the end of the year and we expect the vote on the formal devolution deal to happen at July Full Council.
- With regards to wider LGR, Halton is staying in LCR and Cheshire West and Cheshire East definitely won't be going through any restructuring (which is contrary to some reports heard which is positive).
- Mayoral Elections will be May 2026
- Post May 2026, there will be further local consultation on priorities and the phasing of transfer of powers and funds from Whitehall to the Combined Authority.

National Planning Framework and increases to housing targets for CWaC

As residential development continues across the ward, we can expect to see changes to the volume and routes taken by motorists. This is becoming evident in several locations and needs to be considered as part of the planning process.

Pillmoss Lane (Whitley) is the latest location experiencing this – a report has been submitted to CWaC regarding road condition, increased traffic, road safety for residents and speed limits



Flooding

We are continuing to work with officers, Kathy McArdle (the new Director of Place), Parish Councils, residents and landowners to implement some long-term solutions to the growing number of Flooding hot spots across the ward.

Anderton - Cogshall Lane

Antrobus – Village Centre

Sutton Weaver – Chester Rd (Meadowbank Farm)

Whitley - Town Pit, Greenhill Lane, Pillmoss Lane



Sandbag Policy

The Council is updating its sandbag policy to provide clear and concise information on how CWaC manage our sandbag stock.

What is happening

During recent flood events there has been confusion on the provision of sandbags. The policy aims to outline the Council's responsibility, property owner's responsibilities, and our procedure for the provision of sandbags and their delivery.

CWaC are committed to working with communities affected by frequent flooding, and along with our Emergency Planning team, we are helping to develop community resilience plans to increase awareness and reduce the impacts of flooding.

When it is happening

The policy was presented at the Council's Highway Board on 15th November 2024, the new sandbag policy is now live and can be found on the CWaC website:

New automated technology for reporting missed bin collection

Currently the ways to report a missed bin collection are via the Council's website, the 'Report it' app, the Council Alexa skill or by telephoning the Contact Centre.

To reduce the large volume of calls that are received by the Contact Centre, CWaC are launching call technology that will enable residents to report a missed bin collection at any time of the day.

What is happening

Automated call technology to enable customers to report a missed bin collection is being launched on Wednesday, 19 February.

This new reporting option will have its own telephone number, independent of the Contact Centre. **01244 255801**

The Digital, Data and Technology team have been carrying out rigorous testing prior to launch to ensure that everything is working as it should be. This new way of reporting will be soft launched to the public initially by providing the new telephone number on the Council's website. Once any glitches, if any, have been resolved then the new telephone number will be promoted to residents via social media and other communication channels.

Benefits of adding call automation to this element of the waste service are as follows:

- <u>Improved customer experience</u>: automated lines provide customers with 24/7 access to services.
- <u>Increased customer access</u>: automation of this line will enable customers who do not wish to, or are unable to, engage online to use this new way of reporting.

- <u>Reduction in wait times</u>: by automating this process, the amount of time a customer spends on hold / in call queues (approx. 2 mins 20 seconds) will be reduced. This will lead to increased customer satisfaction.
- <u>Increased flexibility</u>: this new way of reporting will reduce demand on the Contact Centre freeing up time for more complex calls and requests for support.
- <u>Increased efficiency</u>: automated lines can handle high volume of calls simultaneously, reducing the demand on Contact Centre agents.
- Improved customer self-service: automated lines can handle simple customer enquiries such as reporting a missed bin collection, allowing customers to get information they need quickly, without having to wait for a Call Centre agent to assist them.
- Customers who are unable to confirm their details or have an issue with the automated system will still be able to speak to a Contact Centre agent through trigger points in the automated process.
- Any residents reporting a missed bin collection via the Contact Centre, after launch of the new number, will automatically be transferred over to the new line.

When did this happen

• 19 February - the new automated service for bin collection is now live.

Launch of engagement on the Starting Well 0-19 years Service (25 with SEND)

Cheshire and Wirral Partnership NHS Foundation Trust (CWP) is the current provider of the 0-19 Starting Well service. This service is for children and young people aged up to 19 (or 25 for those with Special Educational Needs and Disabilities) and their families.

It includes Children's Centres as well as statutory Public Health services within the Healthy Child Programme (including health visiting and school nursing). The Family Nurse Partnership, an intensive, targeted home-visiting programme for first-time young mothers and families, is also included within the contract.

A Member's Decision Notice in November 2024 gave approval under the Provider Selection Regime (PSR) Direct Award C to award a two-year contract to CWP until 31 June 2027. This two-year period will provide the opportunity to seek views on the future service delivery of the Starting Well service, including the proposed future use of the Children's Centre estate, which forms part of the service.

What is happening

The Council will gather initial ideas and views through a range of face-to-face meetings, engagement workshops and online meetings with parents/carers, children and young people, organisations, Children's Social Care as well as colleagues from teams across the Council.

Engagement opportunities will be available on the Council's consultation platform *Participate Now*, through an online feedback form and ideas board.

These methods will help capture the priorities for residents and professionals that will inform the options for the consultation and subsequent service development.

When is it happening

The engagement phase is open from Monday, 3 March, to Friday, 9 May 2025.

Helping People prepare for later life

There is an ageing population in west Cheshire, with a 24 per cent increase in people aged 65 and above according to the latest Census data, meaning more people are needing to access Adult Social Care services provided by the Council and organisations it commissions.

Depending on individual circumstances and finances, people might need to pay for all or some of the care they receive in the community.

What is happening

The Council is launching a campaign to help people across the borough prepare for later life and access any support they might need.

Managing finances and paying for care services can be a complicated area, with many options available to you depending on your financial circumstances.

While the Council wants to help people who are currently accessing its services to receive any support they might need, it is also aiming to support others as they prepare for later life as we don't know what lies ahead of us with life choices, health or potential care needs.

The Council has created an easy to use, online financial assessment calculator, which will tell you how much you might be asked to contribute towards any care depending on your financial circumstances.

Members Budgets 2025-2026 / Space Hive

The by-election in Runcorn & Helsby means we have a period of *Purdah* where some activity is restricted.

The **Member Budget Award Scheme** for 2025/26 allocates £5,000 to all Members to support local projects and initiatives aimed at improving the quality of life and wellbeing of their communities. Funding is provided to recipients as a discretionary award and is aimed at addressing local priorities for action.



The **Cheshire West Crowd** is the Councils partnership with Spacehive to deliver civic crowdfunding. The approach allows communities to play their part through gaining funding to deliver projects that are aligned to the Council's Borough plan.

The guidelines and restrictions on publicity during the pre-election period started on 28 March 2025.

Member Budgets will open on 1 April 2025, applications can be accepted but will not be formally determined or approved until after the election.

For Cheshire Crowd, project creators can continue to shape, develop, and submit their projects for verification during the pre-election period.

Projects will not go live between 28 March and 2nd May 2025. The deadline for projects to submit for verification is Wednesday 4th June 2025. Campaign dates are set by the project creator.

The Council will not allocate any funds during the pre-election period.

All assessment panels that involve Ward Councillors will also take place outside of the preelection period.
