- Apologies for unavoidable absence Cllr P Harrison offered his resignation as a Cllr before the meeting started. The Council thanked Cllr P Harrison for his time and hard work over the years. Cllr P Harrison started on the Council in 2011 and was the Chairman between 2013 and 2015.
- 2. Members' Declarations of Interest none
- 3. Minutes of the meeting on 17 March 2025 (25/20) RESOLVED to accept the minutes as a correct record of the meeting.
- 4. Matters Arising
 - 4.1 Village shop & tearoom The Council noted the status of the planning application is still with CWAC solicitors. Ward Councillors are pushing forward the application as often as possible.
 - 4.2 Village Clean up Was a success! The council would like to thank all the volunteers that helped throughout the week.
 - 4.3 Playground surface clean up Completed
 - 4.4 Frandley bus stop Response from bus services that no additional stops will be added to the route due to safety concerns. Reports that the bus service has been missing out Antrobus, with school children having to then get picked up in Warrington. Clerk to send a letter of complaint.
- 5. Ward Councillors Cllr P Marshall has a meeting with CWAC Chief Executive Del Curtis to discuss Marbury planning from last year including enforcements. The devolution government consultation is on-going with a report out soon. The National Planning Framework and increases to housing targets for CWAC were discussed. CWAC is updating its sandbag policy to provide clear and concise information



on how it manages it's sandbag stock, with residential properties being provided with sandbags when needed.

An automated system for missed bin collections has been set up (01244 255801) as well as the online system already in place. Helping People prepare for later life was discussed. Access to funding grants through the members budget has reopened.
